
#### DESCRIPTION

This dual Schmitt-trigger buffer is designed for 1.65-V to 5.5-V V<sub>CC</sub> operation.

The SN74LVC2G17 contains two buffers and performs the Boolean function Y = A. The device functions as two independent buffers, but because of Schmitt action, it may have different input threshold levels for positive-going (V<sub>T+</sub>) and negative-going  $(V_{T_{-}})$  signals.

NanoFree™ package technology is a major breakthrough in IC packaging concepts, using the die as the package.

This device is fully specified for partial-power-down applications using  $I_{\text{off}}$ . The  $I_{\text{off}}$  circuitry disables the outputs, preventing damaging current backflow through the device when it is powered down.

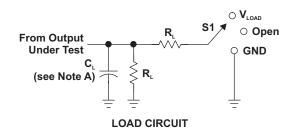



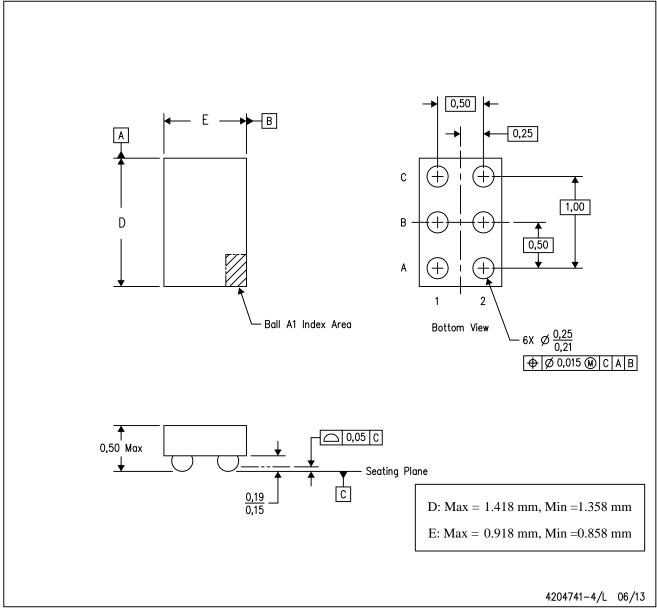
